Sage-Grouse Initiative – EQIP/WHIP funds

- * Focusing on grazing management encouraging landowners to incorporate rest rotation or deferred rotation into current grazing system to improve nesting and brood rearing habitat.
- * Opportunity for landowners to make water developments and fencing wildlife friendly, install escape ramps in tanks, remove electrical lines or water sites near leks and improve riparian herbaceous cover along streams and creeks (only a few of the approved practices).
- ★ Interest in Natrona Co will be making contacts once final worksheets are developed

* April 5, 2010, NRCS, Weed & Pest, Historic Trails RC&D, WGFD and FSA met to discuss how to educate landowners about Russian Olive. Discussed programs

- that could be used to provide financial assistance to landowners if interested in removing Russian Olive. EQIP, WHIP, WRP, CCRP.
- * Apply for Wyoming Natural Resource Trust Fund grant to provide additional assistance and help the landowner who is not eligible for Farm Bill programs.
- ▶ Planning a demonstration for landowners for September 2010. Invite contractors to show what equipment is available and how it works to remove Russian Olive. Also discuss chemicals available to use for follow-up treatment and options for replanting trees, shrubs and grass if needed.
